It is the owner's responsibility to see that her/her project does not adversely affect the drainage of adjoining properties or violate the laws or the rights of other owners. For your protection, please use licensed vendors that have a Certificate of Liability Insurance and Workers Compensation. Please be advised that you as owner will be held wholly responsible to ensure that the work will be done according to approved specifications.

These plans are reviewed for the purpose of determining aesthetic compatibility and compliance of the proposed project with the construction criteria of The Springs Community Association. They are not reviewed for safety or compliance with any government agency. All projects must conform with local zoning and building codes and the homeowner must obtain all necessary permits if approval is granted.

Approvals will be good for 6 months unless otherwise specified.

Construction Deposit Requirements: (Required with submission of application)

The SCA requires a construction deposit to cover any damage, which might result to common property such as roads, bridges, streetlights, utilities, etc. during construction. Amounts required are determined by the ACC or its' agent. Typical fees are: \$1,000.00 for new structures; \$250.00 for modifications of existing structures; and \$200.00 for re-roofing and other projects. No contractor or vendor passes will be issued until the deposits are paid and all requirements of this policy have been met. Deposits will be refunded upon final ACC approval of completed constructions. The property owner is responsible for contacting the ACC for final inspection.

SCA Regulation No. 14 requires that owners provide the SCA business office with evidence that permits have been pulled for renovation work requiring a permit. Owners should bring the permit(s) to the office so we can copy them (or you can provide us with a copy.)

Seminole County Provides the following guidance on when a permit is required:

- For additions and alterations, trade work is generally permitted all together in one permit. For example: a kitchen renovation may include electrical and plumbing permits. The ACC would only be concerned with an interior change line this, if it also included a change to the footprint of the entire home (as in changes to the dimensions of the home).
- Re-roofing (with any material) requires a permit for the rood and any skylights.
- Adding skylights without re-roofing requires a permit.
- Replacing or adding a new fence requires a permit.
- Replacing motorized garage doors requires a permit.
- Adding a pool requires a permit.
- Replacing exterior doors and windows requires a permit.
- Adding a new window or door requires a permit.
- Installing an irrigation system requires a permit.
- Re-plumbing a home or installing a water heater requires a permit. (But no ACC approval required.)
- Repainting does not require a permit.
- Gutters do not require a permit.
- Interior flooring does not require a permit.
